

My Complaint dated 04-04-2016 addressed to Director E.S.I. Health Care, Haryana with subject matter "Recommendations Made For Post Facto Permission To Dr. Aradhana, Medical Officer, ESI Dispensary No.-1, Jagadhari For House Property Purchased By Her"

(b) **Information Relates to period:** 04-04-2016 to till present date.

(c) **DETAILS OF INFORMATION SOUGHT:**

In relation to my above complaint, provide certified copies of:-

1. Documents showing action taken on my Complaint.
2. Written Reply of Civil Surgeon ESI Yamunanagar, if sought and received.
3. Documents by which Dr. Aradhana has disclosed the year of purchase and location of house property for which post-facto permission was granted to her by Haryana Govt on recommendations of this Public Authority.

9 **Sought Information needs to be disclosed for following reasons:-**

- a) **Public Interest Involved:** Dr. Aradhana purchased house property without getting prior sanction. Said House property was not even declared by her in any Annual Property Return. After my above stated Complaint, Civil Surgeon ESI Yamunanagar, Director ESI Health Care Haryana recommended to Haryana Govt. to grant post facto permission of said house property despite the fact that even after complaint, the year of purchase and location of said house property

was not declared by Dr. Aradhana in her explanation in complaint. By such recommendations the O/o Civil Surgeon ESI Yamunanagar and Director ESI Health Care Haryana arbitrarily by-passed the mandatory norms prescribed by Haryana Government for declaration of assets by employees. O/o Secretary Labour Haryana also arbitrarily ignored these norms and granted post facto permission. It shows corrupt practices by Senior officials of this Public Authority and o/o Secretary Labour Department Haryana. Corruption in public authority is public interest matter especially when it relates to acquisition of assets by employees by circumventing applicable rules.

- b) Dr. Aradhana is my wife. We are in litigation in maintenance petition U/S 125 CrPC titled Kushargra vs Dr. Sanjeev Malhotra pending before Court of Hon'ble JMIC Kalka filed by her. Her financial status is of interest to me as it affects quantum of Maintenance amount. I have not been debarred by the Hon'ble Court from seeking information on her financial position under RTI Act. I am entitled to get her financial details and provision of s. 8(1)(j) RTI Act do not apply between spouses when they are in litigation for maintenance u/s 125 CrPC. Refer to para 25 of decision of Hon'ble Central Information Commission in **Prashansa Sharma vs Delhi Transco Ltd in Appeal No. CIC/SA/A/2014/000433 decided on 03-02-2015** and Hon'ble High Court of Delhi in FAO 369/1996 in Kusum Sharma vs Mahinder Kumar Sharma esp. para No.19.20.
